#### EXPLANATORY STATEMENTS

WHEREAS, OWNER is the owner of a parcel of land known as 3512 Green Point Road, East New Market, Maryland 21631 (herein the "Property"), in the East New Market Election District of Dorchester County, Maryland; and

WHEREAS, OWNER and other property owners in the Green Point area of Dorchester County, Maryland are desirous of connecting their respective residential properties to the Sewerage Facility, and have requested the TOWN to extend sewer services to their respective properties and the TOWN has agreed to do so; and

WHEREAS, in order to induce the TOWN to incur the costs and expenses of serving properties in the Green Point area of Dorchester County, Maryland, OWNER has agreed to convey to the TOWN the necessary easements and rights-of-way, gratis, and further agrees to connect the Property to the Sewerage Facility system; and

WHEREAS, LENDER is the holder of a Deed of Trust on the Property from OWNER, dated October 27, 1993 and recorded among the

Land Record Books of Dorchester County, Maryland, in Liber 299, folio 325, and the LENDER joins in the execution of this instrument for the sole purpose of releasing the easements herein granted and conveyed from the operation and effect of said Deed of Trust, but retaining all other rights of the LENDER under said Deed of Trust in and to the remainder of the Property not affected by this conveyance.

AN EASEMENT over, across and beneath a strip of land fifteen (15) feet in width extending from the County right-of-way line of Green Point Road to the grinder pump centered on the Property as constructed and in use and an easement for the electrical service from the electrical meter to the grinder pump five (5) feet in width centered over the electrical line as constructed and in use.


